By decision of this court of 18 November 2013 provisional suspension of payment has been granted to:

the public company

PLAZA CENTERS N.V.

registered with the Chamber of Commerce in Amsterdam with the number 33248324,
corporate seat in Amsterdam,
office address at 1016 EA Amsterdam, Keizersgracht 241.

The court has provided therein that on 3 April 2014, latest, the claims must be filed with the administrator and that the consultation and voting on the plan will take place on 17 April 2014 at 10:00 a.m. before the supervisory judge.

On 11 March 2014, the registry of this court has received a written request from mr. N.W.A. Tollenaar, attorney in Amsterdam, with the purpose of obtaining a postponement of the dates for the filing of claims and the consultation and voting on the proposed plan. Mr. Tollenaar requests on behalf of Plaza Centers N.V. to provide that the filing of claims with the administrator must take place latest on 12 June 2014 and that on 26 June 2014 the consultation and voting on the proposed plan, as to be amended, will take place.

By (fax)letter of 11 March 2014 the administrator, mr. J.L.M. Groenewegen, informed the court that he has no objections against the aforementioned request.

Given the grounds for the request as provided for therein, the court is of the opinion – also taking into account article 264 paragraph 1 in conjunction with article 255 of the Bankruptcy Code – that there is sufficient ground to decide as requested.

The decision

The court decides, under withdrawal of the earlier stipulated dates, that:

- at the latest on **12 June 2014**, the claims must be filed with the administrator mr. J.L.M. Groenewegen, 1090 GS Amsterdam, P.O. Box 94700;

- on **26 June 2014 at 10:00 a.m.** in the Herzbergzaal of this court, located at the Parnassusweg 220, the consultation and voting on the plan will take place before the supervisory judge;
- the administrator forthwith informs all creditors by letter of this decision and of the depositing of the draft plan with the registry of the court and procures that the clerk makes announcement thereof in the Government Gazette (*Staatscourant*) – as meant in article 256 of the Bankruptcy Code;
- the administrator deposits a copy of the list of the provisionally admitted and disputed claims, as meant in article 259 of the Bankruptcy Code, with the registry of the court – *Centrale Balie*, located in Amsterdam at the Parnassusweg 220 – as meant in article 263 of the Bankruptcy Code, in order for that list to be available for inspection by anyone free of charge during seven days prior to the consultation and the voting;
- during the meeting, after the consultation and voting, the administrator shall issue a written report regarding the proposed plan as meant in article 265 paragraph 1 of the Bankruptcy Code.

This decision is made by mr. M.J.E. Geradts and has been proclaimed in the court cabinet on 11 March 2014.

In absence of mr. M.J.E. Geradts this decision is signed by mr. N.A.J. Purcell.
