RECORD AND PAYMENT DATES FOR POLISH BONDS

The directors of Plaza Centers N.V. ("**Plaza**" or the "**Company**") hereby announce in respect of the series A unsecured Polish bonds issued by the Company on 16 November 2010 which are subject to the restructuring plan proposed by the Company in accordance with Article 252 of the Dutch Bankruptcy Code which became binding and effective on 18 July 2014 (the "**Plan**") that the First Interest Payment Date (which is the Interest Prepayment Date and the Mandatory Prepayment upon Exercise Event Date as such terms are defined under the Polish Bond Terms) in respect of the Polish Bonds will fall on 7 January 2015.

The Record Date (as defined in the Polish Bond Terms) for the payment of the amounts due to Polish Noteholders on the First Interest Payment Date will fall on 24 December 2014, i.e. six business days prior to the First Interest Payment Date, as set forth under the Polish Bonds Terms.

Holders of the Polish Bonds should note that in light of the fact that the Company is incorporated in Holland and the shares are admitted to trading on three different stock exchanges (London, Warsaw, Tel Aviv) and certain conditions precedent satisfaction of which is required for the purpose of establishment of the First Interest Payment Date pursuant to the Plan are complex and contingent upon the completion of other preliminary processes in foreign stock exchanges set forth in the Plan. Accordingly, the date of the First Interest Payment Date and the corresponding Record Date (as defined in the Polish Bond Terms) may be subject to change due to circumstances which are not under the control of the Company. The Company will issue an immediate report as it learns of any change and/or delay as mentioned.

All defined terms used but not defined in this announcement shall have the meaning given to them in the Plan.
